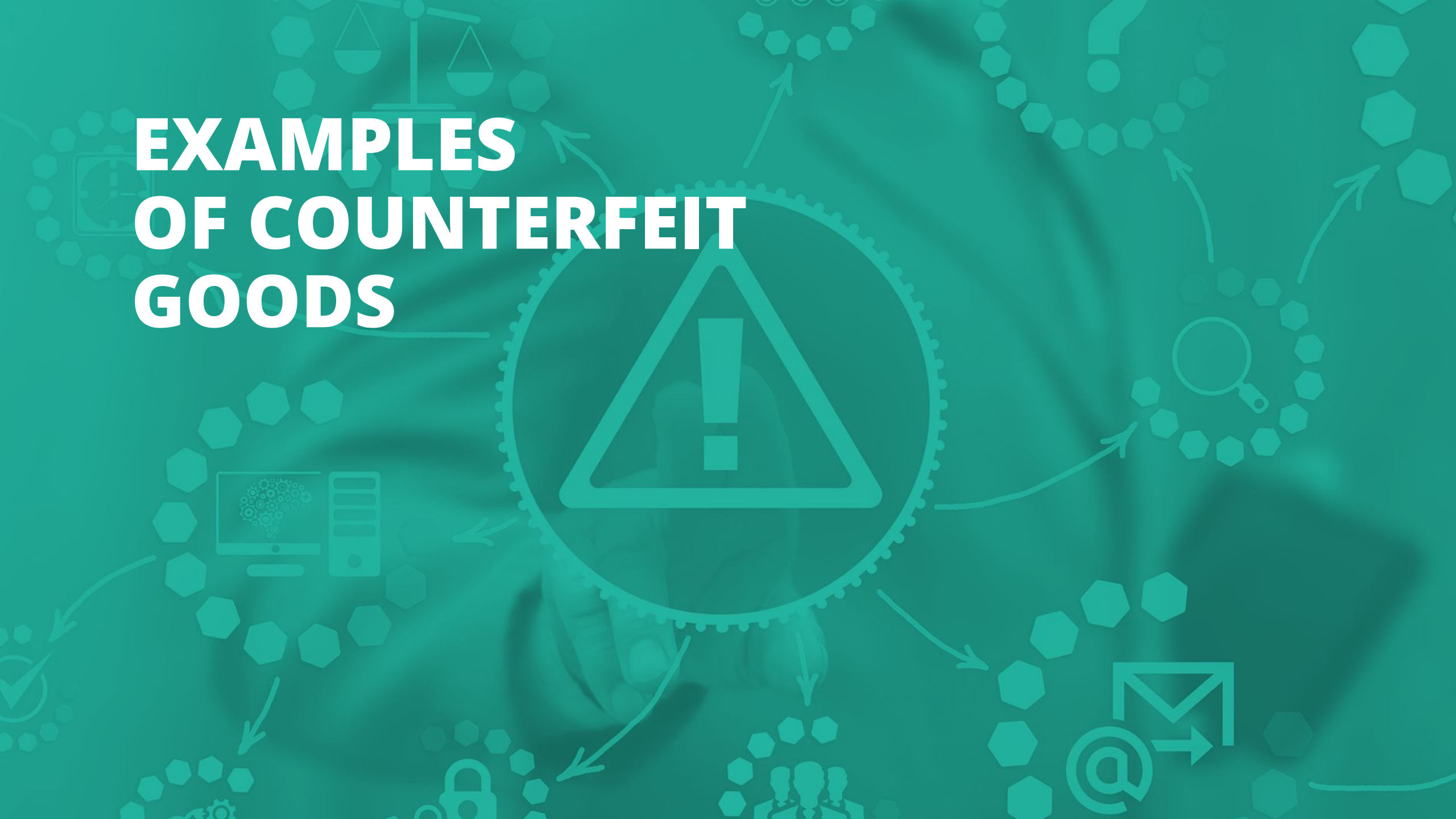



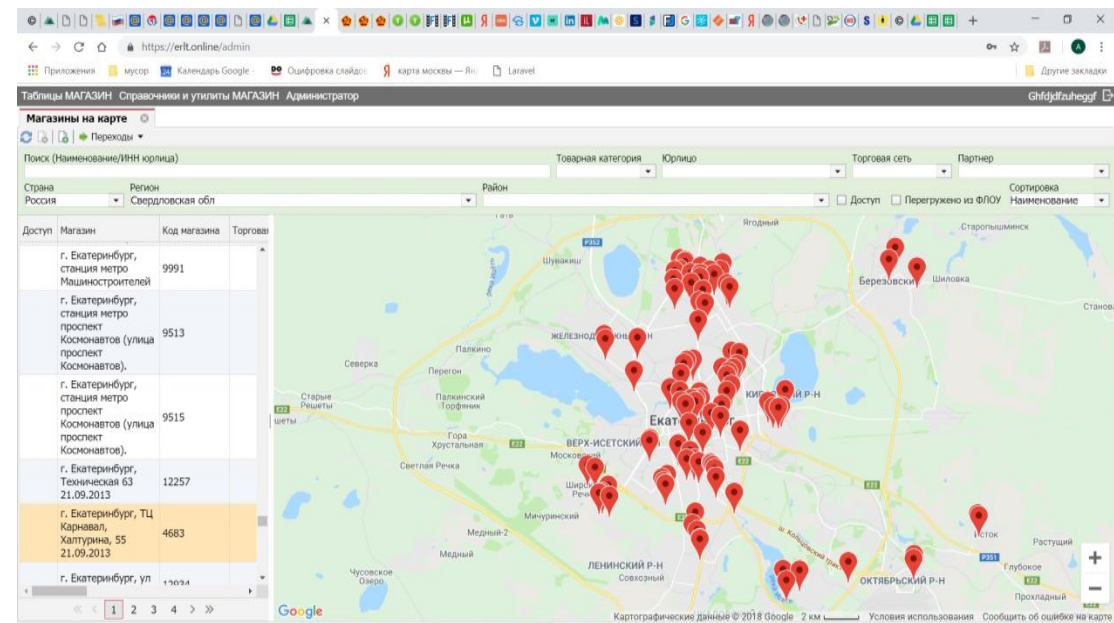

- Notification to all market players about the inadmissibility of infringement of the client's exclusive rights;

- A dozens-fold decrease in the share of counterfeit products in the market to the minimum allowable limits.

- Growing of sales in legal distribution channels.



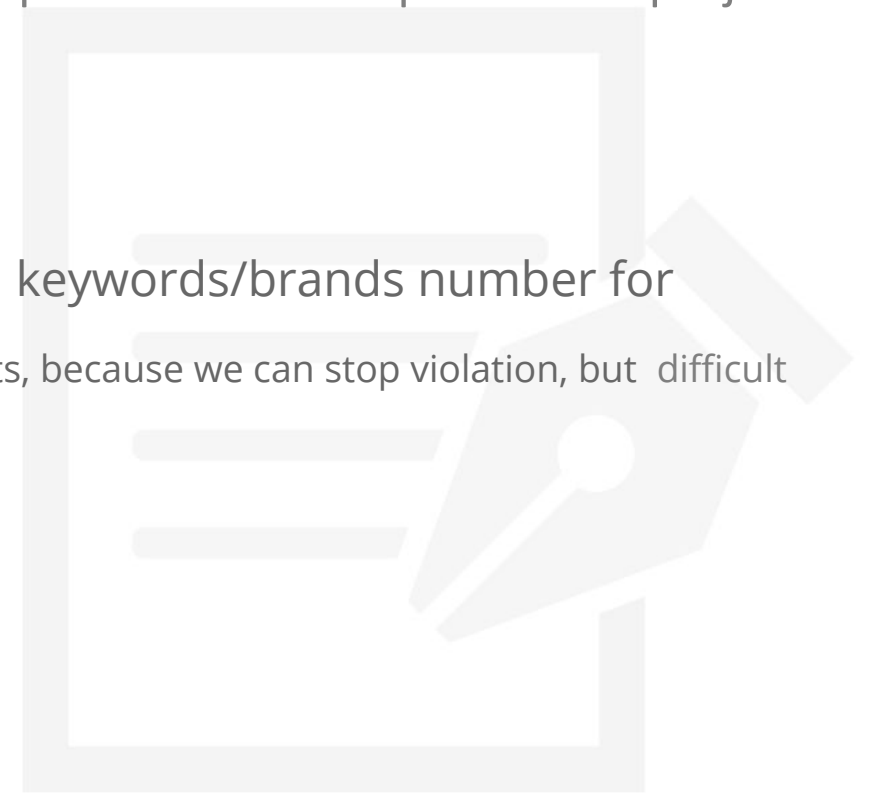

- a set of documents for the objects of exclusive rights, trademarks and copyrights (images, design);
- a Power of attorney and documents on the company's legal status;



# Some examples of successful IP protection cases:

- STIHL (Germany)

Massive IP protection project . More than 1.000 claims against counterfeit distributors (motor oil, chain saws, accessories etc) in 2019 only.

- TM Lecroy (USA) exclusive right protection

Challenging the results of the government tender with delivery of counterfeit goods (oscillographs). Termination of violator's business activity.

- O+ Media (VGTRK and Rostelecom subsidiary company)

Massive IP protection project in Retail and Internet. More than 13.000 claims in retail against counterfeit (Fairy Patrol; Leo&Tig, Mimimishki brands) distributors from 2018.

# Some examples of successful IP protection cases:

- Animacord (brand “Masha and the Bear”)

Massive IP protection project. More than 22.000 claims against IP violators from 2012. Counterfeit representation decreased in 20 and more times (in many different category of goods).

- Early termination of the exclusive rights to TM.

For Novikov Group (restaurants)

- Judicial precedent asserting standards of responsibility.

Against “Perekrestok” federal retail network (A40-82533/2011). Prosecution of uninformed distributor of counterfeit content.
